
(54) Título: PLATAFORMA METALICA DESPLEGABLE Y AUTONOMA PARA LA EVACUACION DE PERSONAS

**(57) Abstract**

Unfoldable and self-contained metal platform for the evacuation of persons comprising an anchoring plate (1) connected to two compasses (3 and 3') provided with longitudinal orifices through which runners (5 and 5') can circulate; the runners are connected to small rods (4 and 4') to which is articulated a tabular body (2); it is comprised of two compasses (6 and 6') at the vicinity of its minor sides which are provided with longitudinal holes through which can circulate runners (8 and 8') terminated by small rods (7 and 7') which, themselves, are articulated to the tabular body (2') at a point close to its internal vertices.

**(57) Resumen**

Plataforma metálica desplegable y autónoma para la evacuación de personas que consiste en una placa de anclaje (1) unida a dos compases (3 y 3'), provistos de orificios longitudinales por los que discurren correderas (5 y 5') unidas a bieletas (4 y 4') a las que se articula un cuerpo tabular (2), disponiendo de dos compases (6 y 6') próximos a sus lados menores dotados de orificios longitudinales por los que discurren correderas (8 y 8') rematadas por bieletas (7 y 7') que se articulan al cuerpo tabular (2') en un punto próximo a sus vértices internos.
