

(54) Title: METHOD AND DEVICE FOR PLACING THE WRAPPERS OF LOLLIPOPS

(54) Título: PROCEDIMIENTO Y DISPOSITIVO DE COLOCACION DE LA ENVOLTURA DE LOS CARAMELOS CON PALO

(57) Abstract

The invention relates to a method and a device for placing wrappers of lollipops by continuously advancing the paper and cutting the latter with a rotational blade (2). After cutting, the head of the lollipop (4) and a push piston grip the paper (1) as the piston rotates thereby wrapping the paper around the head (4) of the lollipop while the ensemble is displaced until the part of the stick (5) located near the head (4) is located under the pliers (7) which closes and finally seals the wrapper (1) on the stick (5), the lollipops being fed directly to the plate (9) through a chain (8) having inlet (10) and outlet (11) loops and bearing means (8.1).



(57) Resumen

Procedimiento y dispositivo de colocación de la envoltura de los caramelos con palo avance del papel se produce de modo continuo mediante corte por cuchilla giratoria (2) y que, tras el momento del corte, la cabeza del pirulí (4) y un pistón empujador sujetan el papel (1) a la vez que el pistón gira produciendo la envoltura del papel sobre la cabeza (4) del caramelo, a la vez se produce un desplazamiento del conjunto hasta que la parte del palo (5) que está en proximidad de la cabeza (4) queda bajo la pinza (7), que es la encargada de cerrar sobre el palo (5) el papel de envolver (1), y sellarlo finalmente, habiéndose producido la alimentación de caramelos con palo al plato (9) en directo, mediante cadena (8) con bucles de entrada (10) y salida (11) y medios (8.1) portadores.
