

**(57) Abstract:** The invention relates to an inflatable pneumatic support (1) for floating cages used to store and/or transport sea fish species. Said support is used to form a collapsible floating cage that can be transported in an auxiliary vessel for subsequent assembling during fishing and before the arrival of the tugs. The cages act as a life support during the wait for the arrival of the tugs with the auxiliary cages. If necessary, said cages can also act as transport cages. The inventive support (1) is provided with anchor bolts (2, 3) which can be used to transport said support and for signs.
