
(54) Título: BANDEROLA MULTIUSO PARA CARAMELO CON PALO

(57) Abstract

The stick is provided with a distinctive element used as a support for publicity or display data relative to the lollipop or relative to the product manufacturer itself; it also incorporates a sticker either of the collectible type or of the publicity type or both simultaneously; the banderole-shaped display support is provided with a fixing system intended to fix the support to the stick of the lollipop; said support offers a large useful surface to display promotions to be publicized and also to deposit stickers.

(57) Resumen

Incorpora en el palo un elemento distintivo utilizado como soporte de publicidad o de presentación de datos relativos al caramelo o relativos a la propia firma fabricante del producto y que incorpora, asimismo, una pegatina bien de un cromó coleccionable, bien de un producto publicitario o ambos simultáneamente, disponiendo el propio soporte expositor, en banderola, de un adecuado sistema de fijación que establece su vinculación al palo y que dispone una amplia superficie útil para mostrar las promociones a publicitar y, también, para depositar unas pegatinas.
