(54) Title: CONTAINER INTENDED TO HOLD AND DISPLAY LOLLIPOPS (54) Título: ENVASE EXPOSITOR Y CONTENEDOR DE CARAMELOS CON PALO (57) Abstract The container consists of a triangular prismatic body which has an inclined face (5) with a series of horizontal linear cavities (6) which extend at different levels between a rear side face (3) and a side lid (4), said cavities being intended to pressure receive the sticks of the lollipops; the side lid (4) has a hinge (7) situated at the intersection between the side lid (4) and the base (2), and about which the side lid (4) can be turned down so as to open an internal receptacle (9) containing the lollipops. (57) Resumen Consiste en un cuerpo de configuración prismático triangular que cuenta con una cara inclinada (5) con una serie de cavidades lineales horizontales (6), que se extienden a diferentes niveles entre una cara lateral posterior (3) y una tapa lateral (4), destinadas al alojamiento a presión de los palos del caramelo, incorporando la tapa lateral (4) una articulación (7) situada en la intersección entre la tapa lateral (4) y la base (2), en torno a la que se abate la tapa lateral (4) descubriendo un receptáculo interior (9) para albergar caramelos con palo.
